2. OSD Coke Private LTD.(Unit 1), Village Amjhore, P.O. Bailapur, District Dhanbad, Jharkhand.





12. **Notification No. S.O. 637(E) and S.O. 638(E) dated 28.02.2014 by MoEF.**


SEIAA noted the notification.
