

Minutes of The 21th meeting of State level Environment Impact Assessment Authority, Jharkhand held on dated 05/07/2014.

The 21th meeting of the State Level Environment Impact Assessment Authority (SEIAA) was convened on 05/07/2014 at the Authority's office. The meeting was chaired by Dr. Gurdeep Singh, Chairman, SEIAA. The following members attended the meeting:

The following issues were discussed in the meeting:-

A. Minutes of the meeting of SEIAA, Jharkhand held on June 7, 2014 were confirmed.

B.

1. **Stone Mine with Crusher at Karhadih & Khargadiha of M/s Bishnu Dev Singh, Vill-Karhadih & Khargadiha, Dist.- Giridih, Jharkhand. (0.594 Ha).**

SEIAA agreed with the recommendations of SEAC. Conditional EC may be granted, that PP shall submit approved mining plan by the competent authority within three months of grant of EC.

2. **Baijudih Stone Mine of M/s Baijudih Stone Works, Village Baijudih, P. O. Dhanwar, District - Giridih, Jharkhand (1.012 Ha).**

SEIAA agreed with the recommendations of SEAC. Conditional EC may be granted, that PP shall submit approved mining plan by the competent authority within three months of grant of EC.

3. **Baijudih Stone Quarry of M/s Md. Saraj Village Baijudih, Tehsil Dhanwar, District - Giridih, Jharkhand (1.012 Ha).**

SEIAA agreed with the recommendations of SEAC. Conditional EC may be granted, that PP shall submit approved mining plan by the competent authority within three months of grant of EC.

4. **Abru Quartz Mine of Sri Keyur Sinha, Vill.-Abru, P.S- Kolhan, Dist.-West Singhbhum, Jharkhand. (16.16 Ha).**


SEIAA agreed with the recommendations of SEAC. TOR proposed by SEAC is accepted & may be issued to PP.

5. **Expansion of existing Sponge Iron Plant to Sponge Iron based Integrated Steel Plant of M/s Sundaram Steel Pvt Ltd., Vill.-Balidih, Dist.-Bokaro, Jharkhand.**

Letter dated 27.06.2014 from PP (Sundaram Steel Pvt Ltd) addressed to Secretary, SEAC has been brought to the knowledge of SEIAA. SEIAA decides to refer back the proposal to SEAC for their recommendation.

EC may be issued with a condition that PP should submit duly approved RWHS from Ground Water Directorate, Govt. of Jharkhand, within three months of grant of EC.

SEIAA perused the order of Hon'ble NGT dated 28.03.14. It was agreed upon that legal opinion may be sought before taking any decision on it.


- 1. Payment of Sitting Fee for site visit.**

SEIAA noted the content of JSPCB letter no- PC/NOC/RNC/43/14/G-2310, dated 1.7.14.

F.

1. Letter no– Env. Poll.- 03/2013(P)-2784 dated 16/06/2014 of Dept. of Forest & Environment, Govt. of Jharkhand .

- a. At present the PP would use existing forest road for transportation of mineral. If he has to install overhead conveyer, that would require clearance under FC Act, which may not be viable for such a small project.
- b. PP is being asked to obtain necessary clearance from Controller General of Explosive before using any explosive.
- c. Necessary conditions have already been incorporated in the EC to keep pollution under control.


