

Minutes of The 12th meeting of State level Environment Impact Assessment Authority, Jharkhand held on dated 21/12/2013.

The 12th meeting of the State Level Environment Impact Assessment Authority was convened on 21/12/2013 at the Authority's office. Dr. Amitava Bandyopadhyay, Member, S.E.I.A.A could not participate in the meeting as per his e-mail vide 19-12-2013. The meeting was chaired by Dr. Gurdeep Singh, Chairman, SEIAA. The following members attended the meeting:

The following issues were discussed in the meeting:-

- A. Minutes of the meeting of SEIAA, Jharkhand held on Dec 16, 2013 were confirmed.
- B. The recommendations submitted by SEAC on the 21 (Twenty One) proposals were discussed and following decisions were taken :

SEIAA considered the recommendations of the SEAC meetings held on October 22 to 25, 2013 and observed that appraisal has not been done properly as stone mining has significant environmental, occupational health, socio-economic issues. SEIAA received similar recommendations of SEAC of the meetings held during November 20-23, 2013 despite discussion on the issue with the Chairman, SEAC in the SEIAA meeting held on 16-12-2013. The proposals are returned to SEAC for re-appraisal particularly with regard to the environmental management scheme with budget providing mitigative measures for environmental impacts including occupational health, socio-economic aspects etc.




