a) **M/s Forum infrastructure Pvt. Ltd. - regarding issuance of EC.**

The SEIAA, Jharkhand went through the application submitted by the Company, Forum Projects, on 07.01.2014 and decided that if the Company gives an undertaking to comply with the conditions put forth in the letter issued by this office letter no.- 173 dated - 19/11/2013 in two months time, issuance of EC may be considered conditionally.

b) **Cases of violation - suggested action by SEAC.**

Proposals regarding cases of violation and action to be initiated shall be sent to State Govt. for instruction to be given to State Pollution Control Board for initiation of action under EP Act.

c) **Annexure 1 of 7/5/2013 minutes of meeting of SEIAA.**

In view of MoEF, GOI's notification dated 09<sup>th</sup> Sept. 2013, in case of B category projects having less than 50 ha area, no certificate as described in sl. No 1, 2, 3 & 9 of annexure I to minutes of meeting held on 07.05.2013 will be required.

d) **Security Agency -continuation of Bhoot Purb Sainik Kalyan Sangh Security Agency**

The work of Security agency is satisfactory, therefore, their services (guards) can be extended on increased minimum wage rate.

e) **Purchase of a PC for the use by the Chairman SEAC.**

Since no computer (PC) is available on DGS&D rate now, in view of in interest of speedy disposal of work, a PC is allowed to be purchased at market price.
