
Issue regarding examine of proposal in respect of Minor Mineral including Stone Mines & Balu Ghat were discussed.


In view of MoEF OM No.- J-13012/12/2013-IA-II(I) ,dated 24 Dec. 2013 SEIAA decided that the proposals would not be received till approved Mine Plan is submitted along with the proposal.

It was realised that problem is arising out due to non-acceptance of proposals without approved Mine Plan. Whereas mechanism of giving approval of Mining Plan is not yet in place. Previously processing of proposals were done without approved Mine Plan and disposed of subject to condition of getting approved the Mine Plan within three months.




In view of circular of MoEF and above stated points, SEIAA is requested to take appropriate decision so that problem may be resolved.


