

Minutes of 5th Meeting of State Level Environment Assessment Authority, Jharkhand held on 14th June 2013.

The fifth meeting of SEIAA was convened on 14/06/2013 at ISM Guest house Dhanbad, the meeting was chaired by Dr. Gurdeep Singh, SEIAA.

A) The Authority in its meeting dated 10/06/2013 had examined the recommendations from grant of EC for State or Central Government Project related to NHAI and other Road Project. SEIAA considered and took the view that SEAC should forward the recommendation by majority and not by any delegated body or a few Member of SEAC.

Secretary, SEAC has informed that consents of Sri SBS Chauhan Member, SEAC, Dr. Manik Chandra Mahata Member, SEAC and Sri S.K Singh, Member SEAC on the recommendations of the SEAC, Jharkhand have been obtained.

Since the majority of members of SEAC have consented for the recommendation, the following recommendations are made.

1. M/s Bhagaundha Stone Mines of M/s Patil Construction village-Bhagaundha, P.o – Ranuna, Dist – Garhwa, Jharkhand (Area 2.023 Ha).

The PP informed that the desired information has been submitted. The papers submitted were examined and found to be as per requirement.

The various conditions which the PP may be asked to comply are attached as Annexure I.


SEAC examined the proposal and recommends to SEIAA for consideration for issue of EC.


SEIAA agrees to the recommendation.


2. Stone Quarry of M/s Madhucon Project Ltd. at Banamghatu, Dist- East Singhbhum, Jharkhand (Area 8.4 acres i.e. 3.4 Ha).

The PP informed that the desired information has been submitted. The papers submitted were examined and were found to be lacking. As per DFO, Jamshedpur's Report the project site falls within 10 KM of Dalma Sanctuary. Also Singhbhum Elephant Reserve falls within 10 KM from project site. Further as per CO's Report the Interstate Boundary is at a distance more than approx. 5 KM (reply against query that is there any Interstate Boundary within 10 KM from Project site.)

As per EIA Notification 2006 any project or activity specified in Category 'B' will be treated as Category 'A' , if located in whole or in part within 10 KM from the boundary of :

- (i) Protected Areas notified under the Wild Life (Protection) Act, 1972;
- (ii) Critically Polluted areas as notified by the Central Pollution Control Board from time to time;
- (iii) Eco-sensitive areas as notified under section 3 of the Environment (Protection) Act, 1986, such as Mahabaleshwar, Pangani, Matheran, Panchamarhi, Dhanu, Doon valley, and
- (iv) Inter-State boundaries and international boundaries:

In view of above the Project cannot be recommended and referred to MOEF as category 'A' project.

SEIAA agrees to the recommendation.

3. Stone Quarry of M/s Madhucon Project Ltd. at Sarengdih, Chandil, Dist – Saraikela-Kharsawan, Jharkhand (Area 8 acres i.e. 3.24 Ha).

The PP informed that the desired information has been submitted. The papers submitted were examined and found to be as per requirement.

The various conditions which the PP may be asked to comply are attached as Annexure I.

SEAC examined the proposal and recommends to SEIAA for consideration for issue of EC.

SEIAA agrees to the recommendation.

4. Stone Quarry of M/s Madhucon Project Ltd. at Tamar, Dist – Ranchi, Jharkhand (Area 10 acres i.e. 4.05 Ha)

The PP informed that the desired information has been submitted. The papers submitted were examined and found to be as per requirement.

The various conditions which the PP may be asked to comply are attached as Annexure I.

SEIAA agrees to the recommendation.


5. Stone Quarry of M/s Keystone Infra Pvt. Ltd. at Namkum, Dist – Ranchi, Jharkhand (Area 6.0 acres i.e. 2.43 Ha)

The PP informed that the desired information has been submitted. The papers submitted were examined and found to be as per requirement. PP also submitted a work order between M/s. Madhucon Project Ltd and M/s. Keystone Infra Pvt Ltd. M/s. Keystone Infra Pvt Ltd has given an undertaking that the boulders from this quarry will only be supplied for Road Building Project (NH 33) for which they have an agreement with M/s. Madhucon for completion of the said project.


SEIAA agrees to the recommendation.


B) Approval was given for hired accommodation of the office of SEIAA and SEAC, Jharkhand.


C) Approval of Authority of the payment of wages to Class- 4 worker as per Gov. of Jharkhand minimum wages rates fixed time to time.
