

## **Minutes of the 60<sup>th</sup> Meeting of State level Environment Impact Assessment Authority, Jharkhand, held on 01 Sep, 2018.**

The 60<sup>th</sup> meeting of the State Level Environment Impact Assessment Authority (SEIAA) was convened on 01.09.2018 at the office of SEIAA, Ranchi. The meeting was chaired by Shri S.E.H. Kazmi, Chairman, SEIAA, Jharkhand. The attendance in the meeting was as follows:-

The decisions taken in the 60<sup>th</sup> SEIAA meeting are as follows –

### **I. SEIAA considered the recommendations made by SEAC in its 60<sup>th</sup> meeting held on 13 & 14.08.2018.**

- a. MoEF & CC Notification dated 25.07.18 regarding procedure for preparation of DSR.

**The Authority considered the matter in light of 59<sup>th</sup> and 60<sup>th</sup> minutes of the meeting of State Level Expert Appraisal Committee, (SEAC) Jharkhand and decided unanimously to ask all the Deputy Commissioner-cum-Chairpersons, DEIAA, Jharkhand to strictly follow the guidelines issued vide SO-3611 (E), dt. 25.07.2018 of Ministry of Environment, Forest & Climate Change in letter & spirit for preparation of district survey reports and to also follow DGPS survey for locating mining leases within the district.**

- b. Site Inspection report of projects by submitted by JUIDCO.

- (i) Convention Centre at Near Project Building, HEC Campus, Ranchi.
- (ii) Civic Centre at Near Project Building, HEC Campus, Ranchi.
- (iii) Ravindra Bhawan at Kutchery Road, Near Jaipal Singh Stadium, Ranchi.

**The Authority examined the recommendations made by the SEAC and after full discussions and deliberations unanimously decided that project proponent of above proposals has carried out prohibited activity, which attract penal action under the provisions of E(P) Act, 1986. SEAC has requested to process the proposals in the light of SO-1030 (E) dated 8<sup>th</sup> March, 2018 of Ministry of Environment Forest & Climate Change, Govt of India. The Authority fully agreed with the recommendations of SEAC.**

- c. CBWTF of M/s Medicare Environment Management Pvt Ltd. Sindri Industrial Area Dhanbad.

**The Authority examined the recommendations made by SEAC along with OM dated-04.04.2016 of Ministry of Environment Forest & Climate Change, Govt of India and decided unanimously to exempt the Public Hearing as the above project lies within the notified Industrial Area.**

- d. Regularization cum Expansion of M/s Santpuria Alloys (P) Ltd at Vill. Manjhladih, Giridih.

**The Authority examined the recommendations made by SEAC and after full discussions and deliberations unanimously decided to accept the recommendations of**

**SEAC in terms of extension of ToR and accordingly extend the validity of ToR from 01.05.2018 to 30.04.2019.**

- e. Mahesh Munda Sand Mine Project on Ajay River of M/s Mehar Developers (Sri Anil Kumar Singh) at Village- Maheshmunda, Nala, Jamtara (16.19 Ha).

**The Authority examined the recommendations made by SEAC wherein SEAC has recommended for Withdrawal of above proposal on the basis of request submitted by project proponent. Hence Authority decided unanimously to accept the recommendations of SEAC seeking for Withdrawal of proposal and accordingly the said proposal was delisted.**

**II. Decision matter related to.**

- a. Mahudi Stone Mine of M/S R.K Stone at Village-Mahudi, P.O- Noamundi, Dist- West Singhbhum, Jharkhand. (1.999 Ha).

**The matter was considered in the light of decision taken in the 45<sup>th</sup> Meeting of SEAC and 58<sup>th</sup> Meeting of SEIAA and after perusal of documents it was found that above matter is concerned with District West Singhbhum. Due to typing error District Sahibganj was mentioned in decision in place of district West Singhbhum. Hence after full discussions and deliberations the Authority decided unanimously that in case of above matter district should be read as West Singhbhum in place of Sahibganj. Accordingly it will be deemed to be modified to such extent.**

- b. Bharat Petroleum Corporation Ltd by BPCL at Village –Anadi, Tehsil- Ormanjhi, Dist- Ranchi.

**The Authority considered the application no-EC/RANCHI/LPG dated -22.06.2018 of Project Facilitator, E&P, East of Bharat Petroleum Corporation Ltd seeking cancellation of the ToR granted by SEIAA Jharkhand.**

**Hence Authority decided unanimously to cancel the ToR of above project proposal which was issued vide letter no-184, dated-26.11.2013 with immediate effect and accordingly such proposal was delisted.**

- c. Chanduka Minerals at Village-Kumarda, Cheria Pahari, Thana- Rajnagar, Dist- Saraikela- Kharsawan.(10.117 Ha).

**The Authority considered the application no-Nil, dated-19.07.2018 of Chanduka Minerals seeking of withdrawal of proposal.**

**Hence Authority decided unanimously to accept the request of Chanduka Minerals and such proposal was delisted.**
