

Minutes of the 72nd meeting of State level Environment Impact Assessment Authority, Jharkhand held on 23rd May, 2019.

The 72nd meeting of the State Level Environment Impact Assessment Authority (SEIAA) was convened on 23/05/2019 in the office of SEIAA, Ranchi. The meeting was chaired by Shri S.E.H. Kazmi, Chairman, SEIAA, Jharkhand. The attendance in the meeting was as follows:-

The decisions taken in the 72nd SEIAA meeting are as follows:-

1. Discussion on matters related to 71st meeting of SEAC held on 16th and 17th May, 2019.

- i. **LPG Bottling Plant of M/S Hindustan Petroleum Corporation Ltd. at Vill – Korna, Tehsil – Barhi, Dist – Hazaribagh, Jharkhand (Proposal No. SIA/JH/IND2/35116/2019).**

The Authority examined the recommendation made by SEAC and it was found that in the postulated recommendation it is not explicitly mentioned whether or not this matter has been transferred to SEIAA, Jharkhand or whether this matter is pending at the level of SEAC, Jharkhand and what type of action is required in this case from the level of SEIAA, Jharkhand?

Project proponent has submitted its representation vide letter no. – LPG/Jamshedpur/21, dated – 22.05.2019 through which request has been made to reconsider the project therefore submitted representation is being sent to SEAC, Jharkhand for reconsideration.

Hence after full deliberations it was unanimously decided that SEAC, Jharkhand should send clear recommendation whether to issue a ToR in this case or delist/reject the project as well as SEAC is requested to quote the provision or clause of E (P) Act, 1986 which prohibit to grant of ToR/EC to the project adjacent to the National Highway and notified forest.

2. Decision on matter related to:-

- i. **Proposed Capacity increase of the existing Cement Grinding / Blending unit from 2.1 MTPA to 3.0 MTPA of M/s Dalmia Cement East Ltd. at Vill.- Kanari, Bokaro Industrial Area, Chas, Bokaro, Jharkhand (Proposal No. SIA/JH/IND/16673/2016).**

The Authority considered the letter no. – DCBL/ENV/EC/19-20/01, dated – 06th March, 2019, whereby project proponent has requested to change the name from “Dalmia Cement East Limited” to “Dalmia Cement (Bharat) Limited” in Environmental Clearance.

The Environmental Clearance has been accorded to above project vide letter no. EC/SEIAA/2016-17/1997/2017/295, dated 08.12.2018 and Further its corrigendum have been issued vide letter no. 85 dated – 14.02.2019.


Ministry of Environment, Forest and Climate Change Govt. of India vide EIA notification, 2006 has laid down the provisions for transferability of Environmental Clearance to the following:-




“A prior environmental clearance granted for a specific project of activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written “no objection” by the transferor, to, and by the regulatory authority concerned on the same terms and conditions under which the prior environmental clearance was initially granted and for the same validity period. No reference to the expert appraisal committee of State Level Expert Appraisal Committee concerned is necessary in such cases”.

Hence after full deliberations on above mentioned fact it was unanimously decided that Environmental Clearance issued vide letter no.- EC/SEIAA/2016-17/1997/2017/295, dated – 08.12.2018 and letter no.- 85, dated – 14.02.2019 favour of “Dalmia Cement East Limited” is being transferred to “Dalmia Cement (Bharat) Limited” with the same terms and conditions under which prior Environmental Clearance was initially granted and for the same validity period subject to satisfactory compliance to all the stipulated specific and general conditions. Dalmia Cement (Bharat) Limited is directed to obtain **Consent to Establish and Consent to Operate** from the State Pollution Control Board in the name of **Dalmia Cement (Bharat) Limited**. In case any **change** is proposed in the scope of the project, the **company shall obtain fresh prior Environmental Clearance**.
